RESOLUTION NO. 128 OF 2023

ADOPTING THE CITY OF BEACON 2024 BUDGET

WHEREAS, pursuant to Resolution No. 2023-109, passed on October 23, 2023, the City of Beacon City Council set a public hearing for November 13, 2023 regarding the proposed 2024 Budget.

WHEREAS, notice for the Public Hearing was published in the Poughkeepsie Journal on November 1, 2023; and

WHEREAS, the Public Hearing was held on November 13, 2023 and continued on both November 27, 2023 and December 11, 2023, during which times the City of Beacon City Council provided opportunity for the public to comment on the proposed 2024 Budget; and

WHEREAS, the City Council has proposed amendments to the tentative Budget presented by the Mayor.

NOW, THEREFORE, BE IT RESOLVED, that the City of Beacon City Council hereby amends the tentative budget to incorporate the Council's changes and adopts the 2024 Budget, as amended.

BE IT FURTHER RESOLVED, that the City Administrator is authorized to administer the adopted 2024 City Budget and enter into contracts and agreements for expenditures authorized within the adopted 2024 City Budget as specified therein specifically and in general for funds allocated within budget lines for:

- i)** general commodities/ services (commonly referred to as a Purchase Contract in accordance with NYS General Municipal Law ("GML") Section 103, for amounts under \$20,000.00;
- ii)** for contracts for services, labor and construction Public Works for amounts under \$35,000.00;
- iii)** for any expenditure under \$35,000.00 and not otherwise subject to competitive bidding under GML 103, provided such purchases are consistent with the appropriations set forth in the approved budget (or as may be amended) and quotes/proposals are obtained in a manner consistent with the City of Beacon's procurement policy;
- iv)** for intermunicipal agreements for the receipt of funds or services by the City or where the expenditure is less than \$50,000.00; and
- v)** applying for, entering into agreements for and receipt of funds associated with grants.



BE IT FURTHER RESOLVED, that a Warrant shall be issued to the Director of Finance by the City of Beacon to collect such taxes in accordance with law, with penalties and interests therein provided.
