RESOLUTION NO. 136 OF 2023

ADOPTING LOCAL LAW NO. 8 OF 2023 TO AMEND THE CHARTER OF THE CITY OF BEACON, SECTION 2.01, CONCERNING COMPENSATION OF THE COUNCIL AND MAYOR

WHEREAS, pursuant to Resolution No. 2023-128, passed on December 11, 2023, the City of Beacon City Council set a public hearing for December 18, 2023 regarding a local law to amend the Charter of the City of Beacon, section 2.01, concerning compensation of the Council and Mayor; and
