To apply for tuition assistance, you must be eligible for free/reduced lunch status with the Beacon Central School District (BCSD). To apply for free or reduced lunches, please visit www.myschoolapps.com and be sure to click the box allowing for the release of info for Beacon Recreation. If you have already applied for free/reduced lunch, please complete the form on the opposite side of this document. If deemed eligible for tuition assistance, you may enroll your child(ren) at a discounted rate of 50% off tuition for up to three days of programming. These spaces (as well as spaces in the program in general) are available on a first-come, first serve basis. To secure your space, please submit the following:

- BCSD Consent To Release Free Or Reduced Price Eligibility Information (opposite side)
 Should you be found to be ineligible for tuition assistance, you will have the opportunity to either pay the balance or withdraw from the program. Once approved, you are approved for the full school year.

Should you be found to be ineligible for tuition assistance, you will have the opportunity to either pay the balance or withdraw from the program with prorated tuition.

All other registration deadlines apply.

In addition to tuition assistance, please note that if your family qualifies for Department of Social Services (DSS) Child Care Assistance, DSS will pay some or all of the tuition for the program. Please speak with us further for more details.
