**ESTABLISHMENT OF STANDARD WORKDAY FOR ELECTED OFFICIALS AND
AUTHORIZING REPORTING TO THE NEW YORK STATE AND LOCAL RETIREMENT
SYSTEM**

WHEREAS, the New York State and Local Retirement System (NYSLRS) has enacted regulations for reporting of elected and/or appointed officials service time for those who do not participate in an employer's time keeping system.

NOW THEREFORE BE IT RESOLVED, the Standard Workday for a Councilmember is seven (7) hours; and

BE IT FURTHER RESOLVED, the City Clerk is directed to report the official record of activity results to the NYSLRS as 4.48 days per month for Councilmember Rhodes and to indicate that, as Councilmember Domanski no longer wishes to participate in the NYSLRS, such information was not submitted for Councilmember Domanski.
