RESOLUTION NO. 77 OF 2024

**REJECTING A NON-RESPONSIVE BID AND AWARDING A CONTRACT
TO SUN UP CONSTRUCTION CORP FOR THE
2024 ACCESSIBLE CURB RAMPS PROJECT**

WHEREAS, the City of Beacon published an advertisement pursuant to General Municipal Law § 103 and Chapter 53 of the Beacon City Code, seeking qualified contractors for COB Bid No. 2024-005, the Accessible Curb Ramp Project; and

WHEREAS, on July 22, 2024, six (6) sealed bids were received and opened; and

WHEREAS, the bid submitted by Raja Contractors, Inc., was found to be the lowest bid, but was also found to be deficient and non-responsive for a variety of reasons, including but not limited to: the Iran Divestment Act Form was not completed as required by law, information regarding references was incomplete, and further information required and requested to be submitted so the City could determine the bidder was a responsible bidder and able to perform the work were not completed in the requested timeframe or provided at all; and

WHEREAS, the City of Beacon reserves the right to reject any and all bids received, including those which are found to be non-conforming, non-responsive and/or deficient; and

WHEREAS, the City Engineer recommends awarding the 2024 Accessible Curb Ramp Project to the lowest responsible bidder, Sun Up Construction Corp., which submitted a responsive and complete bid, for a total base bid amount of Two Hundred and Nineteen Thousand One Hundred and Forty (\$219,140) Dollars and 00/100.

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of Beacon hereby rejects the non-responsive bid of Raja Construction Inc., for the 2024 Accessible Curb Ramps Project; and

BE IT FURTHER RESOLVED, the City Council of the City of Beacon hereby awards COB Bid No. 2024-005, for the 2024 Accessible Curb Ramps Project to Sun Up Construction Corp., in the amount of Two Hundred and Nineteen Thousand One Hundred and Forty (\$219,140) Dollars and 00/100; and

BE IT FURTHER RESOLVED, the City Administrator is hereby authorized to execute an agreement with Sun Up Construction Corp., subject to approval by the City Attorney as to form and substance, and to take all actions necessary to effectuate the intent of this Resolution and to cause compliance with the agreement awarded to Sun Up Construction Corp.
