RESOLUTION NO. 43 OF 2026

AWARDING A CONTRACT TO NEW ENGLAND WASTE SERVICES OF ME, DBA CASELLA ORGANICS, FOR REMOVAL & DISPOSAL OF SLUDGE CAKE FROM THE CITY OF BEACON WASTEWATER TREATMENT FACILITY

WHEREAS, the City of Beacon published an advertisement, pursuant to General Municipal Law § 103 and Chapter 53 of the Beacon City Code, seeking qualified contractors for COB Bid No. 2026-002, Removal & Disposal of Sludge Cake from the City of Beacon Wastewater Treatment Facility; and

WHEREAS, on April 16, 2026, three (3) sealed submissions were received and opened for said bid; and

WHEREAS, after review of the submissions, the apparent low bidder for the project was New England Waste Services of ME, dba Casella Organics (“Casella Organics”); and

WHEREAS, the City’s Engineer Firm recommends awarding the bid for Removal & Disposal of Sludge Cake from the City of Beacon Wastewater Treatment Facility to the lowest responsible bidder, Casella Organics, which submitted a responsive and complete bid for court surfacing services on said project, for a total base bid amount of One-Hundred and Seventy-Three Dollars and Fifty-Two Cents per ton (\$173.52/ton).

NOW, THEREFORE, BE IT RESOLVED, the City Council of the City of Beacon hereby awards COB Bid No. 2026-002, Removal & Disposal of Sludge Cake from the City of Beacon Wastewater Treatment Facility, to Casella Organics in the amount of One-Hundred and Seventy-Three Dollars and Fifty-Two Cents per ton (\$173.52/ton).

BE IT FURTHER RESOLVED, the City Administrator is hereby authorized to execute an agreement and any amendments with Casella Organics, subject to approval by the City Attorney as to form and substance, and to take all actions necessary to effectuate the intent of this Resolution and to cause compliance with the agreement awarded to Casella Organics.
